




Using a search-first approach and integration with additional Provista solutions, Provista Catalog provides a single source of truth for product pricing and contracts, helping you stay informed of changes that could impact your savings and standardization efforts.





HOW DO I ACCESS PROVISTA CATALOG?

Access the Provista Catalog home page by entering the following web address in your internet browser: <https://catalog.provista.com>

If prompted for login information, enter your Provista login ID and password.



After logging in, you are directed to the Welcome page, as shown in the example above. The Welcome page is your starting point to view contract and product news, identify your new and expiring contracts, and search for contract and product information.



GETTING STARTED

SELECT FACILITY

On the Welcome page, your default facility and class of trade (e.g., Long-Term Care) appear in the top right corner.

Use the **Facilities Manager** to view data specific to other facilities, if available. Click the drop-down menu at the top right corner to select from your available facilities.

Select from your most recent facilities, or click View All Facilities to select from all facilities available to you.



If a facility is not displayed under Most Recent Facilities, click **View All Facilities**.

In the Facility Manager, select from your available facilities. If several facilities are available, use the **Enter Facility Name/ID** field to search.

A number in purple indicates the number of child facilities for that facility. Click the down arrow next to the number to expand the list of child facilities.

Select a facility name and click **Apply**.

Click **Set as Default** to automatically view data for the selected facility each time you log in to Provista Catalog.

Note: If no facilities are displayed, you may need to clear your Internet browser data. This process varies depending on the type of browser you are using. In Chrome for Windows, for example, press Shift-Control-Delete on your keyboard to access the Clear Browsing Data menu. Clear the cache and cookies, restart the browser, and log into Provista Catalog.

TOOLBAR ICONS

Icons in the top right provide access to helpful resources, login details, and additional Provista solutions.



Click **User Settings** to identify or log out the current user, or access user preferences





WELCOME PAGE


The Welcome page is your starting point to find contract and product information.



- 1 Search:** Use the Search bar to quickly find information on contracts and products.
- 2 Search by Strategic Programs:** Quickly identify the number of contracts and products associated with specific strategic programs, such as Environmentally Preferred, Novaplus, and Impact Standardization.
Quick Searches: Select this tab to quickly perform common searches using pre-selected criteria.
- 3 Latest News for My Contracts:** View news articles specific to your contracts.
- 4 New and Expiring Contracts:** Identify the number of new and expiring contracts for the selected facility.

SEARCH

Use the Search bar to quickly find product, price, and contract information. First, use the drop-down menu to select the type of search you want to perform:




Next, **enter a search term**, such as product description, contract number, or supplier name.

Click the **magnifying glass (or press Enter)** to search.

Note: Search terms must contain at least two characters. For product and contract searches, you can enter partial search terms. For contract searches, you can also search within a specific category.

In this example, we searched all contracts matched to **suture** that are available to our selected facility. One national contract matched our search term. In the End Date column, we see that this contract is expiring soon.

Partial Search Terms

For **Contract** or **Product** searches, enter partial search terms to view results matched to specific data fields.

In this example, we enter the search term **therm** to view results matching **thermal** and **thermometry**.

- For a contract search, Catalog will attempt to match the search term against the **Contract Description** and **Supplier** fields to provide results.
- For a product search, Catalog will attempt to match the search term against the **Product Description**, **Generic Name**, and **Supplier** fields to provide results.

To use partial search terms for other fields, such as contract number or product number, enter an **asterisk (*)** as a wildcard character. For example, in a contract search, enter part of a contract number preceded by an asterisk to view contracts that match the partial search term but that also have different prefixes.



In this example, we enter ***340** as our search term. The results include contracts with various prefix codes that have **340** in the contract number, as well as results that are cross-referenced to matching contracts (e.g., multisource or replacement contracts).


Search Within

When performing a **Contract** search, use the Search Within menu to quickly locate results by a specific field. As you type in the search field, results will begin to appear in a drop-down menu, sorted by associated fields.




The following fields may be displayed in the menu, based on those available for your search keyword(s):

- Contract Description
- Supplier
- Contract Coverage
- Spend Category



In this example, when searching contracts for the keyword **surgical**, we select “**in Supplier**” from the menu to view results specific to suppliers with names matching that keyword.



Recent Searches

Click in the Search field to view a list of up to three of your recent searches in Provista Catalog.

Select from the list to perform a new search using the same criteria.

Advanced Search Operators

Add search operators in capital letters to your search term to narrow the focus of your search.

Products 


In this example, we search for products matching the term **exam glove** and excluding the term **latex**.

- **AND:** Search for results that match all of the linked keywords.
Example: exam AND glove
- **OR:** Search for each search keyword independently. If two keywords are entered, for example, add OR between them to display results matched to either term.
Example: exam OR glove
- **NOT:** Indicates that the following word will be excluded from the search results.
Example: exam glove NOT nitrile

The search results page displays information, links, and filters specific to the type of search performed.

Use **filters** to narrow the search results by specific criteria.

Click **links** (contract numbers, product numbers, or headlines) to view more details.



View additional pages of results, or adjust the number of results displayed per page.





In this example, we hover over the SD icon for a contract in the search results, and we see that the contract is matched to a Small Business.

QUICK SEARCHES

Select the Quick Searches tab to perform quick searches using pre-defined criteria for contracts, products, and contract news.



All Contracts: View all available contracts (based on your selected facility and user permissions)

All Active Contracts: View all contracts available as of the current date (exclude contracts that are expired or have not yet started)

All Expiring Contracts: View all contracts for which your facility is enrolled that are expiring within the next 90 days. To view expiring contracts by portfolio category, refer to the New and Expiring Contracts section at the bottom right of the Welcome page.

All Future Contracts: View all contracts recently started or beginning soon. To view new contracts by portfolio category, refer to the New and Expiring Contracts section at the bottom right of the Welcome page.

All Products: View all products in the Provista product database

All Contract News: View all articles and information available for your enrolled contracts. To see only the most recent articles for your contracts, refer to the Latest News for My Contracts at the bottom left of the Welcome page.

SEARCH BY CONTRACT

Search by Contracts to quickly locate information on products in the Provista product database, including associated contracts, supplier details, and pricing data.



First, be sure that **Contracts** is selected as the type of search.


Next, enter keywords related to the contracts you want to view, such as **supplier name**, **contract number**, or **product description**.



Click the **magnifying glass** (or press Enter) to search.

When performing a contract search, the data columns shown in the example above are presented by default. You can customize these data columns as needed in User Preferences.

The list of search results provides the following information by default for each contract:

Contract Number: Identify the contract number and associated strategic programs.

Enrollment Status: Identify if the facility is enrolled in the contract (i.e., a tier has been requested and contract pricing has been assigned by the supplier)

Supplier: Identify supplier for the contract; use filters to focus on specific suppliers.

Description: View a brief description of the contract.

Contract Type: Identify if the contract is Custom, Group, Local, or National.

Start/End Dates: Identify effective dates for the contract. If a contract is new, it is indicated in the Start Date column. If it is expired or expiring, it is indicated in the End Date column.

CONTRACT TYPES

Based on your search criteria, the following types of contracts may be presented as results:

Custom: a contract or enhancement established by Provista Custom Contracting for your organization

Group: a contract or enhancement established by Provista Member Business Ventures for a supply network or group in which your facility participates

Local: a contract established by your organization and loaded in Provista Catalog using the Local Contracts Module. (Access to Local Contracts Module is based on your user permissions. Refer to the Local Contracts user manual for details on managing your local contract information.)

National: a contract established by Provista's sourcing team and generally available to all GPO members.

Use filters to narrow your search results by enrollment status, supplier, contract type, strategic program, and other criteria. Place checkmarks next to filter(s) to apply. The list of contracts updates automatically to include only contracts matched to your selected criteria. To remove all filters, click **Clear All**.



GLOSSARY

Class of Trade (COT): Method of identifying purchasing locations, grouped by specific purchaser characteristics, including patient location (acute versus non-acute), prescriber control (clinic versus retail), drug reimbursement (third party insurance), and competition (open door vs. closed door); specific examples of COTs identified for a product in Provista Catalog include Acute Care, Long Term Care, Corporate, Retail Pharmacy, etc.

Contract Price Activation: Provista solution enabling members to request access to contract tier pricing from a supplier

Contract Type: Identifies the category of purchasing agreement used for pricing; examples include National (GPO), Local, Group, and Custom

Contracted UOM: Standard unit of measure used for a product on a specific contract

Cross References: Products that have been identified as similar to the products in a contract; when viewing details for a contract, refer to the Contract Documents section to see if a cross references document exists for the selected contract

Custom: Contract or enhancement established by Provista Custom Contracting for an organization

Direct: A purchasing channel through which items are purchased from a supplier without the use of a distributor

Distributed: A purchasing channel through which items are purchased from a distributor

Distribution Method: Indicates the manner in which products purchased on a contract are delivered to the member; examples include Direct and Distributed

Dual Source Contract: Purchasing agreement made with two suppliers to sell products to members of a GPO

Eligibility: Ability of a facility to view and access contracts, products, and pricing in Provista Catalog, based on Provista membership, Class of Trade, and group or custom contracting participation

Enhanced Therapeutic Class: An advanced drug classification system with multiple levels of specificity, designed to improve formulary maintenance and drug selection

Enrollment: Facility has signed up for a contract (via LOP/LOC or online activation) and has been assigned a tier by the supplier for that contract

Environmentally Preferred: A strategic program by which products are identified as less harmful to the environment; this designation is assigned based on a product's raw materials, distribution methods, packaging, disposal methods, etc.; examples include Latex Free, Mercury Free, Non-Hazardous Waste, Post-Consumer Recycled Content, etc.

Expired Contract: Contract in Provista Catalog for which the end date has passed

Expiring Contract: Contract in Provista Catalog that has an end date within the next 90 days

GPO: Group Purchasing Organization; an entity that helps health care providers, including hospitals, academic medical centers (AMCs), physician clinics, nursing homes and home health agencies, realize savings and efficiencies by aggregating purchasing volume

Group Buy: Contract or enhancement established by Provista Member Business Ventures for a supply network or group in which a facility participates, helping to achieve savings for members on major equipment purchases in over 45 categories

GS1: An international, not-for-profit association dedicated to the design and implementation of global standards and solutions to improve efficiency and visibility of supply-demand chains. GS1 is primarily responsible for barcoding (see GTIN).

GTIN (Global Trade Identification Number): An identification code for trade items developed by GS1. GTINs are assigned to any item (product or service) that may be priced, ordered or invoiced at any point in the supply chain to automate the purchasing process.

Impact Standardization: Provista program that financially rewards a member's standardization efforts while reducing product variation and improving procurement processes on commonly purchased products

Innovative Technologies: A strategic program through which Provista helps you identify breakthrough technologies to improve patient care and reduce the risk of harm to patients and providers

Item Master: Record that lists relevant data for an item. This record may include a description, unit of measure, weight, dimension, vendor, manufacturer, catalog number and ordering quantity.

Local: Contract established by a member organization and loaded to the Provista Catalog
Multisource Contract: Purchasing agreement made with multiple suppliers or manufacturers to sell similar products to members of a GPO

National: Contract established by Provista's sourcing team and generally available to all GPO members

NDC: National Drug Code; a ten-digit, three-segment number published by the U.S. Food and Drug Administration that serves as a unique, universal product identifier included on all over-the-counter and prescription medication packages and inserts in the United States

New Contract: Contracts in Provista Catalog that have recently started or have a start date within the next 120 days

Novaplus: Provista's private-label brand that provides the best financial value and quality on the commodity products that hospitals use most often

Pediatric Preferred Program: Provista's industry-leading portfolio of more than 40,000 high-quality pediatric products

Portfolio: Category of contracts; examples include Medical Products, Pharmacy, and Surgical Products

Price Program: Method of grouping items together in a contract (often by similar criteria, such as Class of Trade) to assign to a specific contract tier

Product Spend Category (PSC): Provista product segment categorization assigned to products in the Provista product database, which is closely aligned with contract categorization methods

Sole Source Contract: An agreement with one supplier to sell a product or group of products to the members of a GPO

Sourcing Code: Data column in the Contract Search results export file; identifies if sourcing for the contract is by Supplier (S), Distributor (D), or Manufacturer (M)

Spend Category: see Product Spend Category

Strategic Programs: Products and contracts that are categorized by criteria intended to meet specific goals or targets for an organization, such as improving standardization efforts or reducing waste; examples include Novaplus, Environmentally Preferred Products, and Impact Standardization.

Supplier Diversity: Provista strategic program that encourages and supports the development of minority, woman, and veteran business enterprises (MWVBES) that meet high-quality standards. Provista assists members with their broader mission of fostering economic development within the communities they serve.

Tier Pricing: Cost for a specific product in a contract by achieving a specific tier on that contract, generally accessible by purchasing a specified volume of products from the supplier associated with the contract

Unit of Measure (UOM): Division of quantity commonly used when purchasing a specific product; examples include: each, box, case, and ounce

UNSPSC: United Nations Standard Products and Services Code is a standard hierarchical convention used to classify all products and services. Levels of UNSPSC categorization include segment, family, class and commodity.
